

Mandan Park District
Board Meeting Minutes
January 11, 2016

The Board of Park Commissioners duly met in regular session on Monday, January 11th, 2016 at Ed "Bosch" Froehlich Meeting Room, City Hall. Those present were President Arenz, Vice President Knoll, Commissioner McPherson, Commissioner Allan, and Commissioner Hatzenbuhler.

President Arenz called the meeting to order at approximately 5:30 pm, CDT. President Arenz asked for approval of the minutes for December 12th, 2015 regular meeting. Motion was made by Commissioner McPherson, seconded by Vice President Knoll. Motion passes.

Unfinished Business:

- Committee update on removal of south side tennis courts. Voted 4 to 1 to remove the south tennis courts over the winter months and the two furthest north would remain intact until we decide what year and get some cost assessments on when we will renovate and rebuild 2 brand new tennis courts. When we build the new ones we will remove the two old ones. Planning on leveling and seeding the area after the tennis courts are removed. Motion was made by Vice President Knoll, seconded by Commissioner McPherson.

New Business:

- Section 1.) Consider appointing two Commissioners and one staff member to the Joint Facilities Committee with Mandan Public Schools. Vice President Knoll made motion to approve Commissioner McPherson, Commissioner Hatzenbuhler, and Director Higlin to be on the board. Seconded by Commissioner Allan. Motion passes.
- Section 2.) Consider for approval of 2016 district policies. Motion was made by Commissioner Allan to approve the Administrative and Raging Rivers policies as presented. Seconded by Commissioner Hatzenbuhler. Motion passes.

Mike Zerr, Park Manager stated that they are still struggling with the All Seasons Arena compressor system. Staff had to go in over the weekend. The colder it gets it will become more of a battle. The fan went out. Hopefully can make it work the rest of the year.
